Participant's Age: _____, and Participant's Birthdate: ____/____/____, hereby consent to my/my child's participation in activities at the Clifton Skatezone, located in Clifton, New Jersey at the expense of and under the sponsorship, direction, control and jurisdiction of the City of Clifton, the Clifton Recreation Department and its agents, servants or employees.

I agree that I am/my child is in good health and physically able to participate in any leagues, clinics, classes, tournaments or activities at the Clifton Skatezone that may include strenuous physical activity. I fully understand that the risk of injury from the activities and programs provided at the Clifton Skatezone is significant. The risk of injury includes, but is not limited to, minor injury such as abrasions and bruises, and more serious injury such as broken bones, muscle pulls and dislocations. The risk of injury also includes catastrophic injury such as permanent paralysis or even death. With full knowledge of the potential risk for injury, I hereby give my consent to participate and/or give my child permission to participate and represent that I have full legal authority to provide such consent.

I further agree that the City of Clifton and/or its agents, members, or employees shall not be liable in the event of an accident, injury or any damage whatsoever arising from participation or presence in or at the Clifton Skatezone.

I grant the City of Clifton my permission to use photographs or video footage taken during participation in the Clifton Skatezone to be used in legitimate City promotions such as brochures, newsletters, promotional publicity or websites without an obligation to provide compensation for use.

I further grant permission to the City of Clifton to authorize medical care for me or my child in an extreme emergency. I hereby give permission to the medical personnel selected by the City of Clifton to order X-rays, routine tests, treatment; release any records necessary for insurance purposes; and to provide or arrange necessary related transportation for my child. In the event that I cannot be reached in an emergency, I hereby give permission to the physician selected by the City of Clifton to secure and administer treatment including hospitalization.

In addition, I fully understand and will abide by all rules and regulations as stated below and posted at the Skatezone:

1. No one is allowed to participate in the activities of the park unless they are wearing **ALL** the required protective gear.
2. No one is allowed to participate in the activities of the park unless they have a signed waiver on file or have a waiver signed by a parent or legal guardian in the presence of a Skatezone employee. Participants 18 years of age or older may sign their own waiver, but must show proof of age at time of signing.
3. All participants must skate in such a manner as to avoid collisions with other skaters. Fighting and other aggressive or disruptive behavior will result in ejection from park.
4. No one may participate in an activity unless they have the appropriate wristband for daily admission.
5. No food or drink is permitted inside the Xtreme Scene, the Skatium or on the Skate Trail. Non-skate equipment, gear or other belongings must be stored in locations outside the skate area. The City of Clifton or its employees are not responsible for personal belongings.
6. No one under the age of 8 is permitted in the Xtreme Scene area of the Clifton Skatezone except during the KickFlip Kids sessions.
7. No contests of any sort are allowed in the park unless organized and run by the Clifton Skatezone (this includes races on the Skate Trail).
8. Shirts must be worn while in the Clifton Skatezone. Proper shoes must be worn while skateboarding.
9. The Clifton Skatezone staff reserves the right to eject anyone at any time for inappropriate behavior.
10. Smoking or drug use is not permitted anywhere within the facility. In addition, use of profanity or abusive language, and/or vandalism is strictly prohibited.
11. Rules for specific events or programs will be provided to registered participants.
12. Bikes are permitted into the facility only on scheduled days.
13. Scooters and motorized vehicles are not permitted in the facility at any time.

I have read this release of liability and assumption of risk agreement, fully understand its terms, understand that I have given up substantial rights by signing it, and sign it freely and voluntarily without any inducement.
